the Complainant/informant

In producing herewith one arrested accused namely Subhash Hazra (33) s/o Badal Hazra of Vill.- Pitambarpur, PS - Patashpur, Dist - Purba Medinipur along with one seized truck bearing No WB 33D/2699 to the effect that on 01.04.17 night while I along with C/214 Siddartha Mondal, C/830 Pralay Kr Mukherjee and C/496 Prakash Ch Mahato vide Raghunathpur PS C.C. No. 1341/17 dtd 01.04.17 were performing special Naka checking duty at Babugram more on Santaldih - Raghunathpur Road under Raghunathpur PS. At about 22:35 hrs one truck bearing No WB 33D/2699 was coming from Dubra side. Accordingly the force accompanied with me signaled the vehicle to stop at Naka Point by enlightened torch lights but the driver of the vehicle did not respond, rather, he dashed the police guard-rail, which is basically used for slowing down the speed of vehicles, followed by a bi-cycle parked beside the main road of Babugram village. Thereafter, I informed the matter to ASI Prabir Mukherjee over R.T. who was engaged in Night Patrolling - II duty with a direction to intercept the said vehicle. In compliance to my instruction, ASI Prabir Mukherjee jammed the Salka more by placing police vehicles as well as road barriers. At about 22:45 hrs the said vehicle reached at Salka more and the police team managed to intercept the vehicle at Salka more. In the mean time, I also reached at Salka more. On demanding the papers of vehicle from the driver, he at first refused to show any papers & started using filthy languages followed by scuffling with our police personnel who were discharging the bona fide govt. duty. In consequences of this, uniform shirt of ASI Prabir Mukherjee torned out & his spectacles got broken. During scuffling, the driver of the vehicle slipped & fell down on the road, resulting mild injury on his person. Accordingly he was placed for medical examination at Raghunathpur Super Specialist Hospital.

As the driver of the vehicle namely Subhash Hazra has committed an offence of preventing or deterring the public servant from discharging his duty & also he has committed an offence of rash and negligent driving causing damage of public property. Hence I seized the vehicle under proper seizure list duly signed by the witnesses and arrested him after obtaining all formalities. I do hereby register a specific case as suo-moto vide Raghunathpur PS Case No 51/17 dt 02.04.17 U/S 279/427/323/186/353 IPC & 3 PDPP Act 1984 against the driver of the vehicle namely Subhash Hazra s/o Badal Hazra (33) of Vill.- Pitambarpur, PS – Patashpur, Dist – Purba Medinipur.
