Sir.

I, SI Gopal Ch. Man S/O Shri Dhirendranath Man of Gopinathpur, P.S Beliatore Bankura now posted at Santuri PS, Dist Purulia do hereby lodge a written complaint against Asit Paramanik (aged 45 approx.) S/O Late Ratar Paramanik of Vill-Rangadanga, PS-Santuri, Dist-Purulia, owner of a tea & pokora shop located near Rangadanga High Shool Morh under Ramchandrapur G.P, P.S- Santuri ,Dist. Purulia to the effect that today on 29.06.2020 while I along with C/702 Anal Kanti Banerjee & NVF960 Rajib Singh Sardar both of Santuri PS as per direction engaged in special mobile duty within Santuri PS area, reference Santuri P.S G.D.E No. 1026 dtd. 29.06.2020 and CC No- 2334/20 dated 29.06.2020 for implementation of Government rules regarding lockdown Disaster Management Plan. While we proceeding towards Kotaldih Railway gate and reached in front of the above noted shop at about 11:45 hrs. found that the above noted person was selling Goods to the customers in his shop without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation. I took photograph of the aforesaid shop along with owner in presence of Gorachand Pal S/O Pasupati Pal of Lalgarh (2) Madhu Chakrobarty S/O Anath Chakrobarty of Kinaidih, (3) Jagannath Kar S/O Shankar Kar of Kotaldih all under Santuri P.S, Dist. Purulia and other customers who were left the place on seeing the Police team.

So, there is every reason to believe that the above noted person was selling goods from his shop without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule.

Therefore, I pray a specific case may kindly be started against accused Asit Paramanik (aged 45 approx.) S/O Late Ratan Paramanik of Vill-Rangadanga, PS-Santuri, Dist-Purulia U/S- 188 IPC and 51 (1) (b) Disaster Management Act, 2005 as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
