

The above named complainant beg to state as follows:-

- That the complainant is the mother of the deceased namely Rumpa Paramanik, The accused no. 1 was the husband of Rumpa Paramanik and the accused no. 2 and 3 are the mother-in-law and brother-in-law respectively of the above deceased by relation.
  - That the marriage of deceased Rumpa Paramanik and accused no. 1 was solemnized on as per Hindu laws and sastrask/ following all types of formali. \ prevelling in their society.
    - That as per demand of the bride groom's famil the complainant and her husband who is witness no. paid a sum of rupees fifty two thousand Rs. 52,000 and two vories of golden ornaments utensiles and bedings along with other connected articles.
      - That as usual the daughter of the complainant went to her matrimonial home duly accompained by her husband and started living there as husband ar wife with other family members.
        - That just after one month from the date of ma the above named accused persons made one plan and again demand a sum of rupees fourtv thousand only from the father home of Rumpa Mordana with a ore which was due at the time of marriage. had on her. Romna Paramanik informs





the matter to her parent home. And after receiving the information the complainant intimated all the accused persons that they had/have cleared all as per demand at the time of marriage, so questio of "dues" does not arises and they are moneytorily poor so not to possiable for them to meet any extra demand.

- failed to fulfil their illegal demand, So the above named accused persons started in human fortures both physically and mentally unon Rumpa Paramanik. As such tortures extended to maximum decrees, i.e. by not providing required quanitity of food, clothes and other needs rater she was subjected to in human tortures of beating by above named accused persons now and then and without any cogent reasons, and on 05.11.2016 when the complainant came to her paternal home then she stated before the complainant and other family members that her life was danger and they would kill her with a plan for only non fulfilmer of their more demand.
  - 7. That on 4.12.2016 above named accused persons for not fulfilment of their demands jointly forcibly pouned her body by Karosin oil setfire on her body and when they saw condition

the matter to her paternal House. Hearing this the complainant and her family members rushed to sadar Hospital and saw the serious condition. Then the complainant shifted her for better treatment to Rajendra medical college Ranchi.

Be it mentioned here when the complainant was with injured Rumpa Paramanik, she hard the above story from the mouth of Rumpa mordana.

- 8. That after cure and on requested of the accused persons the complainant on good faith gave necessary permission to stay in her materimonial home. And after some days when her condition was not good or serious then they admitted her at Tata Main Hospital and she died on \$2.12.2016.
  - loudging complain before police personal of woman p.s. Shatbandh Purulia, but the complainant came to learn p.s. concern not to take necessary steps then the complainant informed the matter to S.P. Purulia but off no good. Now for getting appropriate reliefs the complainant file this case for proper legal action against the accused persons and this is the caused for delay.
    - 9. That the accused persons have committed a crimin
