Dear Sir,
I do hereby lodge complaint empowered by enabling the Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Prakash Sahu, S/O - Ajit Sahu was enjoying electricity unauthorisedly i.e. hooking from the nearest LT OH Pole for construction purpose of his under construction building at the same location. And for that purpose he has committed theft u/s 135 (1)(a) of the Electricity (Amendment) Act-2007.
On 25/01/2017 at about 2:20 pm I Sri Mozuli Mahata, Station Manager, Bundwan Customer Care Centre, WBSEDCL along with:-

1) Yeasin Mondal, Linesman, Bundwan ccc, WBSEDCL
2) Tapas Rajwar, Contractor's worker, Bundwan ccc, WBSEDCL
entered the premises of Prakash Sahu, S/O - Ajit Sahu, Vill - Kendajhore P.S - Boro, Dist - Purulia, and inspected the premises. During inspection theft of electricity was detected, i.e. he was using electricity dishonestly by drawing illegal hooking from the nearest LT OH line of WBSEDCL i.e. u/s 135(1)(a) was detected.

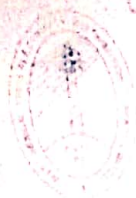
