entered the premises of Nityananda Sing, S/O- Late Jatindra Sing of Village- Chalka, P.O- Kharidnara, P.S.- BORO, Dist - Purulia and inspected his/her premises and found that: he was enjoying electricity by direct hooking from WBSEDCL's LT line unauthor

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Two nos. Bulb (one 100Watt & one 60Watt)
- 2) Two nos CFL (2 X 20Watt)
- 3) Fan - one no. (1 X 60Watt)

out of which we seized the following -

- 1) Approx 10mtr single core cable with two pin male-female Plug
- 2) Approx one mtr flexible PVC cable (two core)
- 3) 100 watt bulb (one no.) with holder

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 04:20PM on dated 15.02.17. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.
