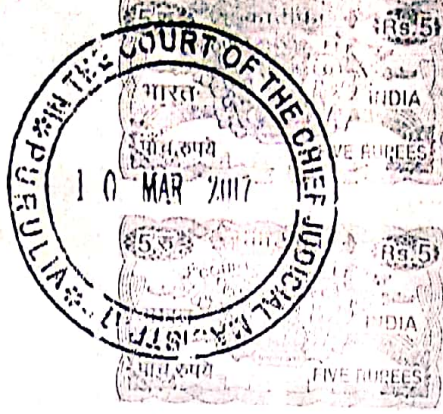

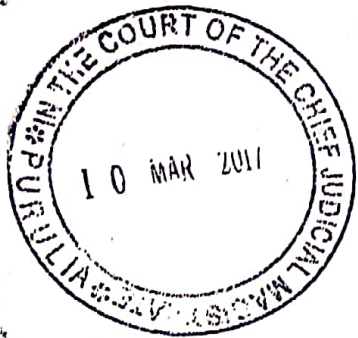

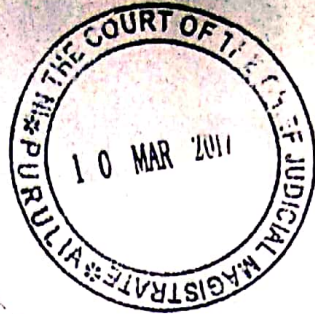

The humble petition on behalf of the above named complainant ,

Most respect fully beg to state as follows :-

- 1) That the complainant Smt. Malati Soren is the legally married wife of accused No.1 , Sukumar Soren. They are Santal by cate and Hindu by religion. Their marriage was solemnised on 27th day of Baisakh of 1410 B.S. years according to their customary rites and famalities revelant in their community . The marriage of the parties is stillsubsisting .
- 2) That accorsed No.2 Monindranath Soren is the father of Sukumar Soren and Malati Soren is the mather of Sukumar Soren and Ramkamal Soren is the brother of Sukumar Soren , and Lakhiram Soren is the grand father of Sukumar Soren and accd. No. 7 is the 2nd wife of Sukumar Soren .
- 3) That as she was subjected to torture and cruelty both Physical mentall by the accused and for that, she has instituted a cirminal case U/S -498A I.P.C. against her husband and other members of his family the ~~said~~ said case was acquitted before the Ld. Court of C.J.M. Purulia on 18-9-13 and another as registered as misc case No. 141/16 U/S 125 Cr. P.C. .

The said case was presented before the Ld. Judicial Magistrate 2nd court which is pending in that said court of N.D. on 9/3/2017 for P.W.

4) That on the date of occurrence her husband Sri Sukumar Soren contracted 2nd marriage with accused No.7 at the direct instigation and abatement of the remaining accused persons. The 2nd marriage was performed in the same ~~mannar~~ manner procedure and formality as required by the santal community as stated in para 1 of this petition, There was also barber who performed the professional work in the marriage but his name was not known the said barber and other accused persons were asked by witnesses to refrain from such illegal and immoral act/ marriage but without any result. The Accused persons were also aware. That the present complainant wa / is the legally married wife of the accused No.1 Sukumar Soren . Thus al the accused persons most illegally and forcibly managed the second marriage in the same way and under similar customs and formalities as described in para1 or the this petition. Thus the accused persons are liable to be punished 494, 494/109 I.P.C. .

5) That because of the poverty and for collecting the full particulars of the accused persons, there is delay in filing the case .
