Person namely Bimal Kumbhakar (44 Yrs approx), S/O- Bhaktu Kumbhakar of Vill- Bari, P.O - Bari, PS - Boro, Dist - Purulia with seizure of (1) 12(Twelve) sealed bottles of 80-up DILKHUSH Country Spirit each Bottle contains 600 ml., M.R.P. Rs. 30/- each, total value (30*12) = 360/- (2) 12(Twelve) sealed bottles of Kingfisher Strong Premium Bear each, Bottle contains 650 ml. M.R.P. Rs. 100/- each, total value (100*12) = 1200/- (3) 6 (Six) sealed bottles of Officer's choice prestige whiskey each Bottle contains 180 ml. M.R.P. Rs. 100/- each, total value (100*06) = 600/- (4) 6 (Six) bottles sealed McDowell No1. Celebration Rum each Bottle contains 180 ml. M.R.P. Rs. 90/- each, total value (90*06) = 540/-. Total value of above noted seized articles (360 + 1200+600+540) = Rs. 2700/- which was seized under proper seizure list.

I beg to submit that today (16.04.17) in between 17.45 hrs to 18.15 hrs a raid was conducted in the Gumti shop of Bimal Kumbhakar (44 Yrs approx), S/O- Bhaktu Kumbhakar of Vill- Bari, P.O. - Bari, PS - Boro, Dist - Purulia. On acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling Country Spirit and liquor which were kept in Gumti shop. On demand he failed to produced any valid documents in respect of selling of liquor from the Gumti shop. As such he was arrested at 18.20 hrs u/s 67 B.E.Act and also seized also the articles under proper seizure list in presence of witnesses, u/s 67 A (C) B.E.Act which enclosed here with. Out of seized articles one bottle of each taken out as sample with sealed & labeled. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The above noted arrested accd. namely Bimal Kumbhakar (44 Yrs approx), S/O- Bhaktu Kumbhakar of Vill- Bari, P.O - Bari, PS - Boro, Dist - Purulia Committed offence u/s 46 A (C) B.E. Act. 1909 for unauthorized possession and sale of country spirit and foreign liqueur from his Gumti shop at Bari, P.S. Boro Dist- Purtula.

It may note here that during raid (01) C /887- Manaranjan Dey, (02) C/ 470 Somnath Nag accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E.Act. 1909 may kindly be started against Bimal Kumbhakar (44 Yrs approx), S/O- Bhaktu Kumbhakar of Vill- Bari, P.O - Bari, PS - Boro, Dist - Purulia
