Sub: Request for lodging F.I.R. against arrested accused Rajesh Bauri & 01 others.

Sir,

In producing here with 02 (Two) arrested accused namely 1. Rajesh Bauri (22 Yrs) S/O Dinesh Bauri of Bankra Para Ward No-12 Nanduarra, PS-Raghunathpur, Dist- Purulia 2. Azad Mukhi (21 Yrs) S/O Lt. Rajesh Mukhi of Children Park, PS-Adra, Dist- Purulia along with Memo of Arrest.

I SI Parikshit Mahato of Adra PS do here by lodged a complaint against above noted 02 accused persons to the effect that on 05.07.2020 at about 21:55 hrs while I was on patrolling duty at PS area vide Adra PS C.C No-2245/20, found 08-10 persons consist of their 02-03 Motorcycle gathered at Adra to Arrah Village Pitch Road beside Maharam Maidan, After seeing the police party 06-08 persons consist of their respective 02-03 Motorcycle were fled away. Rest persons also tried to fled away but after reached the spot we managed to detained above noted 02 persons. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road or they could not able to give reasonable ground for this gathering. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And orders of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020. As such the following persons violated the order during this pandemic situation. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. Accordingly the following 02 (Two) persons were arrested at 22:15 Hrs. and 22:25 Hrs. after maintaining all formalities regarding arrest and brought them to P.S. I offered them for medical treatment but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
