In producing here with 03 (Thou) arrested accused namely (1) Aatish Prasad (23 Yrs) s/o- Lt. Punwa Prasad of Loco ColonuJhupri near SaiMandir (2) Bikram Das (21), s/o- Ajaj Das of Kamlasthan, (3) SanjuAich (22) S/O KanuAichof Kamlasthan, PS-Adra, Dist-Puruliaalong with Memo of Arrest and seizure list.

(01) One Black colourBazaz AvengerMotor Cycle vide Reg. No- WB 82C/6605 from the possession of Aatish Prasad (23 Yrs) s/o- Lt. Punwa Prasad of Loco ColonuJhupri near SaiMandir, PS-Adra, Dist-Purulia.

I SI SubrataSadhuof Adra PS do here by lodged a complaint against above noted 03(Three) accused persons to the effect that on 09.07.2020 at about 21.55 hrs. while I was on Evening mobile duty at PS area vide C.C No- 2292/20 found few persons with 02-03 motorcycle were gathered near Ram Mandir More under Adra P.S DistPurulia without maintaining social distance and without wearing musk. I aware them and directed them to send back at their respective destination as they were violating the Govt. order. But after several attemptsthey pay no heed to me. Finding no other way we tried to detained them. After seeing the Police party they were trying to flee away after a hot chase we managed to detained above noted 03(Three) persons with 01 motor cycle from the possession of a accused person and found that they were not wearing any mask and cloth covered to their mouth and nose. COVID - 19 Pandemic guidelines is going on throughout the country as well as District of Purulia in view of Pandemic of COVID-19 outbreak. They were disobeyed the guide lines of Covid 19 pandemic and to maintain social distance but they did not pay any heed. Consequently, it reasoned to believe they violated the order and disobeyed the direction during this Pandemic situation duly promulgated by Govt. of India vide order No. 40-3/2020-DM-I(A) dated 1/5/2020read with the order of Govt. of West Bengal vide Memo No 272-CS/2020 Dated 30/06/2020 and 382-I.S.S/2M-24/2020 dtd.02/07/20. As such the following persons violated the order during this pandemic situation. Moreover the detained persons were refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. Accordingly the following 03 (Three) persons were arrested in between 22.05Hrs to 22.25 Hrs. after maintaining all formalities regarding arrest and seizure and brought them to P.S. I seized the above noted Motor cycle from the possession of accd. Aatish Prasad from the spot. I offered them for medical checkup but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
