I SI, Dipanakar Sarkar, O/C Arsha PS do hereby lodged complaint Suo-motu against following arrested accused persons to the effect that, today (09.07.20) at about 15:05 hrs, during my mobile duty (Arsha PS GDE No 261 dated 09.07.20) with (1) ASI Sanjoy Dey, (2) C/984, Dhananjay Mondal, C/744, Susanta Chakraborty of Arsha PS and C/499, Milan Bera, C/751, Surajit Nath & C/936, Hiru Sar of SAP 7th Bn, camp at Arsha PS, vide Arsha PS CC No 95/20 dated 09.07.20, had been at Arsha Hat tola area and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such, all they violated the Govt. Order during this COVID – 19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as the society. Accordingly, all they were arrested between 16:05 hrs to 16:45 hrs and brought to PS.
