In producing herewith 01 (One) accused person namely Bhutnath Machuar (45 Yrs), S/O-Lt-Chhutubabu Machuar of Vill-Burda, PS-Baghmundi, Dist-Purulia to the effect that on 04.07.2020 at about 15:05 hrs while I SI Sudhir Kumar Mahato along with force C/779-Sudarshan Kuiry of SAP 11th Bn. Camp and JC/549 Arun Kumar Duley both of Baghmundi PS were performing mobile duty vide Baghmundi PS GDE No- 172, Dated- 04/07/2020. During my mobile duty when myself along with force reached at Koreng More at 15:35 hrs and found above noted person was roaming aimlessly near at Koreng More on Baghmundi- Jhalda Main Road without mask or its alternative. I detained him. On being asked the above accused person disclosed his identity as above but could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above person violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is going on till now. Moreover the detained person is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic.
