The above name complainant begs to state as follows:

- 1) That the complainant is the legally married wife of the accused person no-1. Their marriage was solemnized on 17th Falgun 1420 B.S as per Hindu rites and customs and also solemnized all the formalities by exchange of garlands, putting on vermilion, Home etc, and their marriage is still subsisting.
- 2) That at the time of marriage as per demand of the husband of the complainant and other inmates, the mother of the complainant had to pay cash of Rs. 71,000/- along with golden and silver ornaments, furniture's, utensils etc., but they were not happy.
- That after marriage the complainant was brought to her matrimonial house by her husband i.e. the accused person no-1 and started to reside as husband and wife and the inmates of the family were used to resides in the same mess and under the same roof.



4) That initially the complainant was while residing at her matrimonial house relating with the in-laws were well and good in course thereof the complainant gave birth a female child namely Tanushree Singha who is aged about 2½ years. After birth of the said female child behavior of the accused persons and his inmates started to change toward complainant.

The accused person no-1 and his inmates was not happy as the complainant gave birth a female child first, the complainant in spite of rough behavior of the present complainant somehow managed to stay at my matrimonial house for good days to be come in future.

And in such circumstances they demanded a cash of Rs. 50,000/- to be paid by the father of the complainant as additional dowry and when such illegal demand was not fulfilled they inflected more torture upon the complainant.

5) That the accused persons also did not allow the complainant to talk any other persons and in such



circumstances the accused person no-1 assaulted the complainant without any reason.


That when the complainant was admitted in hospital for delivery and when the accused person and his inmates learnt that the complainant gave birth a female child then they turned hostile against the accused person and refused to take the complainant in their house.

And for about one year from the birth of the female child the accused persons neither provide any cash or kind nor they have taken any information. Nor they have paid any farthing when the complainant was in the hospital for delivery.

- 7) That the complainant bearing all such of torture continued to stay her matrimonial relationship / house.
- 8) That the opposite party is a habitual drunker and he almost all the night assaulted the complainant in a very routine manner and they also gave out that unless the said money be paid then they will not allowed the complainant to stay in their house.



- 9) That in such condition with persistent torture and continued for no fault upon the complainant, the accused person no-1 and his inmates drive out the complainant on 1st January-2019 after good assault and since then the complainant is residing at the paternal house, but neither the accused person nor any inmates tried to take back the complainant in their house for conjugal their relationship as before.
- 10) That thereafter, the complainant lodged one complainant before the Officer-in-charge Bagmundi P.S. against the accused persons but the said Officer-in-charge did not taken any legal action, after passage of considerable time then the complainant lodged another complaint to the Superintendent of Police, Purulia but with same fate.
- 11) That the accused persons committed various offences punishable under the Indian penal code including section 498A/323/34 I.P.C for which they are deserved to be punished under the law.



12) That no legal action yet been taken against the accused persons from the side of the Police for which the complainant is under compelling circumstances is filing this complaint before the ld. Court.

It is therefore, prayed that your honour may be pleased to sent the petition of complaint to the Officer-in-charge Bagmundi P.S. for treating the same as FIR under section 156(3) for investigation.
