In this meeting the Pradhan and Upa-Pradhan of said GP along with elected members of GP and Panchayet Samity were present. During discussion 1.Khetramohan Saw and 2.Rajesh Saw both S/O-Not Known of Vill-Kuchi, PS-Baghmudi, Dist-Purulia started to shout and on protest used criminal force upon me and block official staffs and badly created hindrance to perform the Govt. duties in presence of a good number of local villagers. After that we somehow managed to complete the said meeting and after intervention of police we are able to leave the place.

Hence I pray before you to start an enquiry and take necessary action against above mentioned persons under proper section of law.
