Sir,

In producing herewith 01(One) accused persons namely Bholanath Gope (38 Yrs), S/O-Angad Gope of Vill-Laldih, PS-Baghmundi, Dist-Purulia to the effect that on 15/07/2020 at about 17:45 hrs while I SI Biswajit Banerjee along with force 1) C/162 Umesh Mandi, 2)C/779-Sudarshan Kuiry, 3) C/228 Tanmoy Jana all are of SAP 11th Bn. Camp at Baghmundi PS and JC/549 Arun Kumar Duley of Baghmundi PS were performing mobile duty vide Baghmundi PS GDE No- 731, Dated-15/07/2020. During my mobile duty when myself along with force reached at Charida More at 19:25 hrs and found above noted person was roaming aimlessly at Charida More without mask or its alternative. I detained him. On being asked the above accused person disclosed his identity as above but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & State Govt. has passed order to wear mask in the public place mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt is order no 382-1.S.S./2M-24/2020 Dtd 02.07.2020.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained person is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request.

Hence I pray before you to start a specific case against the above noted person under proper section of law.
