Sir,

In producing herewith 05(Five) accused persons namely 1.Debasish Mukherjee (33 Yrs), S/O-Balaram Mukherjee, 2.Susanta Bishtu (50 Yrs), S/O-Lt-Ishan Bishtu, 3.Kanchan Modak (33 Yrs), S/O-Lt-Panchkari Modak all are of Vill-Baghmundi, 4.Mantu Kumar(30 Yrs), S/O-Abhinash Kumar of Vill-Torang, 5.Parikhshit Kumar (35 Yrs), S/O-Dukhaharan Kumar of Vill-Saragdih, all are of PS-Baghmundi, Dist-Purulia to the effect that on 23/07/2020 while I SI Sudhir Kumar Mahato along with force 1) C/564 Prasad Majhi and 2) JC/549-Arun Kumar Duley both of Baghmundi PS were performing mobile duty vide Baghmundi PS GDE No-1082, Dated- 23/07/2020. During my mobile duty when myself along with force reached at Kisan Mandi, Baghmundi at 14:25 hrs and found above noted persons were roaming aimlessly at said place without mask or its alternative. I detained them. On being asked the above accused persons disclosed their identity as above but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & State Govt. has passed order to wear mask in the public place mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt is order no 382-1.S.S./2M-24/2020 Dtd 02.07.2020.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
