In producing herewith 03 (Three) accused persons namely (1) Falahari Mura (25 Yrs), S/O- Samal Mura of Vill- Kudna, (2) Sripada Mura (29 Yrs), S/O- Sambhu Mura, (3) Buddheswar Mura (27 Yrs), S/O- Mukunda Mura both of Vill- Sukridobha and all are PS-Baghmundi, Dist- Purulia along with seized articles such as 1) one improvised country made old gun, 2) one iron rod having length of 3 ft 11inch 3) one steel made Torch with battery (03 shell, Eveready company) 4) one iron-wooden made knife having length 01 ft, I SI Amaresh Das beg to submit that today (27.07.2020) I along with force namely 1)C/1319 Soumen Koley, 2) Cl 1478 Dhirendranath Mahato, 3) Cl 1454 Ashok Mahato 4) Cl 1055 Santimoy Samanta were performing anti crime night mobile duty at P.S. area vide C.C. No-961/2020, Dated- 26.07.2020. During performing such duty at Link road, Bagmundi in pursuance of telephonic source information we left for Banshitar bridge (Bagmundi area, entry point from Balarampur side) at 23.15 hrs after informing the matter to OC Bagmundi PS.

We approached to the P.O i.e the Banshitar Bridge at 00.15 hrs on foot by keeping vehicle at a distance of 500 meters away (approx) and surrounded the same quickly and surreptitiously. As it was odd hours of night and lonely place there was no local people. We heard suspicious human voice at a distance from 25-30 meters to converse among themselves in Bengali dialect. After having heard this I along with forces challenged the suspicious character as police party and they started to fled away from the spot. But we instantly apprehended 03 persons. On being asked they disclosed their identity as (1) Falahari Mura (25 Yrs), S/O- Samal Mura of Vill- Kudna, (2) Sripada Mura (29 Yrs), S/O- Sambhu Mura, (3) Buddheswar Mura (27 Yrs), S/O- Mukunda Mura both of Vill- Sukridobha and all are PS-Baghmundi, Dist- Purulia . Rest 03-04 persons fled away from the spot on the darkness as well as geography of the locality. After the apprehension of the above noted persons we searched them. During search one improvised country made old gun was recovered from the right hand grip of accused Falahari Mura (25 Yrs), S/O- Samal Mura of Vill- Kudna, PS-Baghmundi, Dist-Purulia and one iron rod having length of 3 ft 11inch from the right hand grip and one steel made Torch with battery, from left hand grip of accused Sripada Mura and made Knife having length 01 ft from the right waist of accused one iron- wooden Buddheswar Mura.

On interrogation the accused persons disclosed their names and address as on the overleaf and stated that they assembled there for committing dacoity on Balarampur - Baghmundi pitch road during this night on any merchandise truck or from any businessmen. On demand the above noted miscreant failed to produce any valid license or relevant document of any competent authority in favour of possessing illegal firearms and to acquire the same. So, I arrested them informing the ground of arrest, observing all arresting guidelines and seized the above noted articles and labeled them duly signed by the police witnesses as there were no local witnesses available there. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possession for committing dacoity on Balarampur - Baghmundi pitch road, actually committed an offence punishable U/S- 399/402 IPC and 25/27/35 Arms Act. In view of this I arrested the above noted 03 (Three) accused persons and seized the weapons from their possession by preparing seizure list on the spot duly signed by the witness and brought them to P.S.

Hence I pray before you to start a specific case against the above noted accused person under proper section of law and arrange its investigation.
