To The Officer in charge Balarampur P.S Dist-Purulia

Today (17.07.2020) myself SI Bhudev Ch. Kuiry along with force to were engaged in mobile duty vide CC NO- 2987/2020, GDE No- 827 dt- 17.07.2020 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At about 17:25 hrs, when myself along with force reached at Bansgarh Hospital more area under Balarampur P.S. we found 02 (two) persons namely 1) Kadam Mohammad (36 yrs) S/O- Idrish Mohammad of Vill- Dhundhikanta, Rasuldih, P.O- Gerua, P.S- Balarampur, Dist.- Purulia, 2) Khagen Majhi (19 yrs) S/O- Jogindra Majhi of Vill+Po-Gerua, P.S- Balarampur, Dist.- Purulia, were spitting in public places after consuming Gutka. I asked them not to do that in public places as there is a huge probability of spreading COVID-19 through the droplets of spitting but they didn't pay any heed to me, rather, started spitting carelessly in public place which led to violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID-19 pandemic. So finding no alternatives we arrested all the above noted 02 (two) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 02 (two) persons came out from their home and spitting in public places for making fun, though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No-272-CS/2020 dated 30.06.2020 and Order vide Memo No 127/1(61)/Health dtd 16.07.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case may kindly be started against 02 (two) persons namely 1) Kadam Mohammad (36 yrs) S/O- Idrish Mohammad of Vill- Dhundhikanta, Rasuldih, P.O- Gerua, P.S- Balarampur, Dist.- Purulia, 2) Khagen Majhi (19 yrs) S/O- Jogindra Majhi of Vill+Po- Gerua, P.S- Balarampur, Dist.- Purulia.
