Today (23.07.2020) myself S.I Bhudev Ch. Kuiry along with force to were engaged in mobile duty vide CC NO- 3076/2020, GDE No- 1127 dt- 23.07.2020 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At about 17:35 Hrs, when myself along with force reached at Balarampur Chowk Bazar area under Balarampur P.S. we found 03 (three) persons namely 1) Krishnapada Mahato (26 yrs) S/O- Prafullya Mahato of Vill- Chirugora, P.S- Baghmundi, Dist.- Purulia, 2) Manoj Maddi (30 yrs) S/O- Bhakta Maddi of Vill- Gobindapur, Banbandha, P.S- Balarampur, Dist.- Purulia & 3) Mir Alimuddin (30 yrs) S/O- Mir Kuddush of Vill-Rasuldih, P.S- Balarampur, Dist.- Purulia without having mask were moving aimlessly and violation the Lock down order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, we intercepted them at Balarampur Chowk Bazar and making chaos with the Police party so finding no alternatives we arrested all the above noted 03 (three) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 03 (three) persons came out from their home without having mask and violation the Lock down order, they moving aimlessly for making fun, though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 & Memo No- 283-CS/2020 date-21.07.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case may kindly be started against 03 (three) persons namely 1) Krishnapada Mahato (26 yrs) S/O- Prafullya Mahato of Vill- Chirugora, P.S- Baghmundi, Dist.- Purulia, 2) Manoj Maddi (30 yrs) S/O- Bhakta Maddi of Vill- Gobindapur, Banbandha, P.S- Balarampur, Dist.- Purulia & 3) Mir Alimuddin (30 yrs) S/O- Mir Kuddush of Vill- Rasuldih, P.S- Balarampur, Dist.- Purulia.
