Respected Sir,

In producing here with one arrested accused person namely Arjun Saw (55 yrs) S/O- Lt. Chuman Saw of Balarampur Tata Road near Saraf Petrol Pump, P.S.- Balarampur, Dist.- Purulia along with seized 38 (thirty eight) bottles KINGFISHER Labelled Strong Premium Beer each bottles contains 650 ML in sealed condition & 21 (twenty one) bottles (DIL KHUSH) Labelled Country Sprit each bottles contains 600 ML in sealed condition (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 19:05 hrs. I received a credible source information that one Arjun Saw (55 yrs) S/O- Lt. Chuman Saw of Balarampur Tata Road near Saraf Petrol Pump, P.S.- Balarampur, Dist.- Purulia is selling country sprit without any valid license from his own Suravi Hotel near Saraf Petrol Pump beside Balarampur Tata Road under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Suravi Hotel near Saraf Petrol Pump beside Balarampur Tata Road to work out the source information. Thereafter we reached at Suravi Hotel near Saraf Petrol Pump beside Balarampur Tata Road at about 19:45 hrs as per source information and held raid in the Suravi Hotel of Arjun Saw.

During search with the help of accompany with force, we found that the said person is selling country sprit bottles (DIL KHUSH) in his own Suravi Hotel. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said Beer & Country sprit. Accordingly, I seized all the sealed Beer & Country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle of Beer and one bottle of Country Sprit as a sample. Total 38 (thirty eight) bottles KINGFISHER Labelled Strong Premium Beer each bottles contains 650 ML in sealed condition & 21 (twenty one) bottles (DIL KHUSH) Labelled Country Sprit each bottles contains 600 ML and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Arjun Saw (55 yrs) S/O- Lt. Chuman Saw of Vill- Balarampur Tata Road near Saraf Petrol Pump, P.S.-Balarampur, Dist.- Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
