Today (29.07.2020) myself SI Sanjay Diger along with force JC/971 Sanjay Gulimajhi, JC/368 Ramhari Mandal to were engaged in Spl. mobile duty vide C.C NO- 3161/2020, GDE No- 1366 dt- 29.07.2020 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At about 14:25 Hrs, when myself along with force reached at Balarampur Station Bazar area under Balarampur P.S. we found 13 (thirteen) persons namely 1) Gurucharan Karmakar (38 yrs) S/O- Sohan Karmakar of Vill- Nischintapur P.S- Barabazar, Dist.- Purulia, 2) Dharu Singh Sardar (28 yrs) S/O- Amal Singh Sardar of Vill- Hetyadih, P.S- Balarampur, Dist.- Purulia, 3) Santosh Sahis (35 yrs) S/O- Budhu Sahis of Vill- Hetyadih, P.S- Balarampur, Dist.- Purulia, 4) Dilip Mahanty (58 yrs) S/O- Lt. There is every chance to believe that the above noted 05 (five) persons came out from their home to making fun and halla at Balarampur market area, though lockdown is going on throughout all over West Bengal in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-I (A) Date- 24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 and recent Memo No- 283-CS/2020 date-21.07.2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life. Hence I arrested them after maintaining all arrest formalities regarding arrest guided by NHRC and Apex Court of India.
