Sub: Request for lodging F.I.R. against arrested accused persons (1) Kartik Paramanik (32 y) S/o-Lt. Rajani Paramanik (2) Sanatan Paramanik (32 y) S/o-Lt. Narattam Paramanik both are of Vill-Gobindapur, PS-MGM Dist-East Singhbhum, Jharkhand.

In producing herewith the two arrested accused persons namely (1) Kartik Paramanik (32 Sir. y) S/o-Lt. Rajani Paramanik (2) Sanatan Paramanik (32 y) S/o-Lt. Narattam Paramanik both are of Vill-Gobindapur, PS-MGM Dist-East Singhbhum, Jharkhand along with one seized Black & Violet colour Motor Cycle bearing Reg No-JH05Ch/6935, I SI Biswajit Sarkar of Bandwan PS. beg to report that as per your kind order vide Bandwan PS GDE No-138 Date-04.07.20 & CC No-1968/20 Date-04.07.2020 on today i.e 04/07/2020 at about 16.05 hrs while myself along with force were performing day patrolling duty at Bandwan Bazer area and found the following persons with their Motor Cycle was coming to Bandwan Bazer without any face cover mask as well as without maintaining social distance. Police party detained them at Bandwan Bazer under Bandwan PS. On being asked the following persons could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to lockdown. On enquire it revealed that the persons are the inhabitant of East Singhbhum under Jharkhand state area and without any valid reason/valid pass they were moving at Bandwan Bazer. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt, of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, 272-CS/2020 dated 30.06.2020 are in force. As such the following persons violated the order during this pandemic situation. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spare infection of disease dangerous to life. Accordingly the following persons were arrested and seized 01 motor cycle from their possession after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to P.S

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/269/270/34 IPC & Read with section 51 of Disaster Management Act, 2005.
