
Sub: - Request for lodging F.I.R. against arrested accused person Debabrata Mahato (age-26 yrs approx) S/O-Kalo Baran Mahato of Vill-Banspahari, PS-Belpahari, Dist-Jhargram.

Sir,

In producing herewith the one arrested accused person namely Debabrata Mahato (age-26 yrs approx) S/O-Kalo Baran Mahato of Vill-Banspahari, PS-Belpahari, Dist-Jhargram along with one seized Black colour Honda Dream Motor Cycle bearing Reg No-JH-05BC/0954. I SI Madan Ch. Supakar of Bandwan PS, beg to report that as per your kind order vide Bandwan PS GDE No-352 Date-09.07.20 & Spl. CC No-30/20 Date-09.07.2020 on today i.e on 09/07/2020 at about 14.15 hrs while myself along with force were performing Spl. Motor Cycle mobile duty at Bandwan Bazar area and found the above noted person with his Motor Cycle was coming to Bandwan Chwak Bazar without any face cover mask. Police party detained him at Bandwan Chawak Bazar under Bandwan PS. On being asked he could not able to give any satisfactory answer for his movement on road and public place at that time, where unnecessary public movement restriction is going on due to lockdown. On enquire it revealed that the person is the inhabitant of Jhargram District and without any valid reason he was moving at Bandwan Bazar. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, 272-CS/2020 dated 30.06.2020 are in force. As such the above noted person violated the order during this pandemic situation. Moreover the detained person was refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused person also tried negligently to spare infection of disease dangerous to life. Accordingly, the above noted person was arrested and seized 01 motor cycle from his possession after maintaining all formalities regarding arrest and seizure & prepared arrest memo and brought him to P.S.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/269/270 IPC & Read with section 51 of Disaster Management Act, 2005.
