

Majhi of Bandwan PS, beg to report that as per your kind order vide Bandwan PS GDE No-964 Date-23.07.20 & CC No-2205/20 Date-23.07.2020 today i.e on 23/07/2020 at about 17.15 hrs while myself along with force were performing Spl. mobile duty while we reached at Chawk Bazar under Bandwan PS and found the above noted persons were coming from different sides without any face cover mask and gathered at Bandwan Chawk Bazar. Police party detained them at Chawk Bazar under Bandwan PS. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to lockdown throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020 and order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020, 218-CS/2020 dt-30.05.2020, 272-CS/2020 dt. 30.06.2020 & 283-CS 2020 dt-21/07/2020 are in force. As such the above noted persons violated the order during this pandemic situation. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spare infection of disease dangerous to life. Accordingly, the above noted persons were arrested after maintaining all formalities regarding arrest and prepared arrest memo and brought them to P.S.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/269/270/34 IPC & Read with section 51 of Disaster Management Act, 2005.
