Parikhit Mahato (age-24 yrs) S/O-Lakhindar Mahato of Vill-Chowra, PS-Patamda, Dist-East Singhbhum JKD along with one seized white & blue colour Apache Motor Cycle bearing chassis No-MD637CE75K2L00830 & Engine No. CE7LK2300525, I SI Biswajit Sarkar of Bandwan PS, beg to report that as per your kind order vide Bandwan PS GDE No-916 Date-22.07.20 & CC No-2194/20 Date-22.07.2020 today i.e on 22/07/2020 at about 17.05 hrs while myself along with force were performing Spl. mobile duty while we reached at Bombay Chawk more under Bandwan PS and found the above noted persons with one Motor Cycle rider (SI no-11 Parikhit Mahato S/O-Lakhindar Mahato) were coming from Bandwan Chawk Bazar without any face cover mask. Police party detained them at Bombay Chawk under Bandwan PS. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to lockdown. On enquire it also revealed that one person (Parikhit Mahato) is the inhabitant of Jharkhand and without any valid reason he was moving at Bandwan Bazar. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, 272-CS/2020 dated 30.06.2020 are in force. As such the above noted persons violated the order during this pandemic situation. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spare infection of disease dangerous to life. Accordingly, the above noted persons were arrested and seized 01 motor cycle from the possession of motor cycle rider (Parikhit Mahato) after maintaining all formalities regarding arrest and seizure & prepared arrest memo and brought them to P.S.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/269/270 IPC & Read with section 51 of Disaster Management Act, 2005.
