In producing here with one bike having Registration No- JH 05AP 3831 along with 03 persons namely (i) Gunadhar Karmakar (32 Yrs) S/o- Parikshit Karmakar (ii) Kartick Karmakar (35 Yrs) S/o-Sristidhar Karmakar both of VIII- Salboni, PS- Bandwan, Dist- Purulia (iii) Jagadish Karmakar (23 Yrs) S/o- Ganesh Karmakar of VIII- Ulda and 13 (Thirteen) numbers of arrested persons namely- (iv) Dinabandhu Orang (20 Yrs) S/o- Manohar Orang of Vill- Kaipara (v) Uttam Mahato (35 Yrs) S/o- Satish Mahato of Vill- Muradih (vi) Arun Sing Sardar (24 Yrs) S/o- Jighur Sing Sardar of Vill- Laxmanpur (vii) Arun Ch. I beg to state that today (22.07.2020), I was directed to find out whether the lock down has been implanted properly at Barabazar Market area or not. This refers to Barabazar PS GDE No- 1359 Dtd. 22.07.2020. Accordingly, I had been to market area at about 09.15 hrs. At around 10.05 hrs I found that a gathering appeared in front of Barabazar Namoparao bye pass without mask and seen the Police party some of them tried to fled away. After that as per order we detained the above motorcycle and other persons.

I requested the bike rider to produce the papers of the bike having Registration No- JH 05AP 3831. All 03 (Three) sl. No. 1 – 3 failed to produced any papers in support of their bike. They were also found without helmet and mask while riding the vehicle dangerously. Accordingly, I seized the blke under proper seizure list in between 10.15 and 10.35 hrs. On interrogation this three persons stated their identification as (i) Gunadhar Karmakar (32 Yrs) S/o-Parikshit Karmakar (ii) Kartick Karmakar (35 Yrs) S/o-Sristidhar Karmakar both of Vill- Salboni, PS- Bandwan, Dist-Purulia (iii) Jagadish Karmakar (23 Yrs) S/o- Ganesh Karmakar of Vill- Ulda, PS- Barabazar, Dist- Purulia. Then I asked others detainees regarding their Identity and they disclosed their Identity sl. No. 4- 16 as (Iv) Dinabandhu Orang (20 Yrs) S/o- Manohar Orang of Vill- Kaipara (v) Utlam Mahato (35 Yrs) S/o- Satish Mahato of Vill- Muradih (vi) Arun Sing Sardar (24 Yrs) S/o- Jighur Sing Sardar of Vill- Laxmanpur (vii) Arun Ch. Das (25 Yrs) S/o- Kalipada Das of Vill-Laxmanpur (viii) Durgacharan Mahato (18 Yrs) S/o- Bangshidhar Mahato of Vill- Jeria (ix) Balaram Soren (23 Yrs) S/o-Haradhan Soren of Vill- Narayanpur (x) Ablnash Gope (20 Yrs) Yudhisthir Gope of Vill- Pattoria (xl) Santanu Singha Deb (38 Yrs) S/o- Patit Paban Singha Deb (xii) Biddadhar Mahato (29 Yrs) S/o- Banamali Mahato of Vill- Kerrow (xiii) Lambodhar Mahanty (40 Yrs) S/o- Lt. Ukil Mahanty of Vill- Kukurcharl (xiv) Priyabrata Singha Deb (27 Yrs) S/o- Ashoke Kumar Singha Deb of Vill- Bagalbandh (xv) Javed Alam (21 Yrs) S/o- Jabbar Alam of Vill- Barabazar Namopara all are PS- Barabazar, Dist- Purulia (xvi) Rohin Hembram (23 Yrs) S/o- Laxmikanta Hembram of VIII- Hatiadih, PS- Boram, Dist- East Singhbhum. I asked them reason for none wearing of mask in Covid-19 pandemic situation. They failed to explain any valid reason for non wearing mask in spite of govt. order.

They cannot give satisfactory answer about such type of activities like non wearing of mask and and running motor cycles dangerously with three persons without using helmet's. All 16 (Sixteen) persons also failed to give satisfactory answer for such type of movement in indiscipline manner. They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt order vide Order No- 272-CD/2020 Dtd. 30.06.2020 duly promulgated vide Memo No- 382-I.S.S/2M-24/2020 Dtd. 02.07.2020.

Accordingly, I arrested them for Disobedience to order duly promulgated by public servant; after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. More over they driven the vehicle on public way in rush and negligently as to endanger human life.

All the process was done in between 10.05 hrs and 10.45 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present as witness in the seizure process. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to I.C Barabazar through duty officer ASI Manas Kumar Pan for taking necessary action as per law. I handed over all the relevant papers, seizure list, seized motor cycle, Memo of arrest, Inspection Memo.
