Today (11.07.2020) myself SI Partha Sarathi Shit along with JC/1347 Sushil Mahato, and JC/859 Ujjal Banerjee were engaged in mobile duty vide Hura PS CC NO- 2011/20 GDE No- 429 dt- 11.07.20 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At about 16:25 hrs, when myself along with force reached at Lalpur morh area under Hura P.S. we found 06 (Six) persons namely 1. Debasish Mahato (35yr.) S/O- Nagendranath Mahato of Vill- Karmatard, PS- Hura, Dist- Purulia, 2. Surya Narayan Murmu (38 yrs.) S/O- Krishna Ch. Murmu of Vill- Hatikundar, PS- Hura, Dist- Purulia, 3. Biplab Mahato(20yrs.) S/O- Malinda Mahato of Vill- Rahamda, PS- Hura, Dist- Purulia, 4. Sasadhar Mahato(60 yrs.) S/O- Lt. Premchand Mahato of Vill- Layekdih, PS- Hura, Dist- Purulia, 5. Dhananjay Mahato (25 yrs.) S/O- Ranjit Mahato of Vill- Layekdih, PS- Hura, Dist- Purulia, 6. Alope Mahato (30yrs.) S/O- Ranjit Mahato of Vill- Layekdih, PS- Hura, Dist- Purulia without having mask were moving aimlessly. We warned them regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but they did not pay any heed and also making chaos with the Police party. So finding no alternatives we arrested all the above noted 06 (Six) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 06 (Six) persons came out from their home without having mask and moving aimlessly for making fun, though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case may kindly be started against 06 (Six) arrested persons namely 1. Debasish Mahato (35yr.) S/O- Nagendranath Mahato of Vill- Karmatard, PS- Hura, Dist- Purulia, 2. Surya Narayan Murmu (38 yrs.) S/O- Krishna Ch. Murmu of Vill- Hatikundar, PS- Hura, Dist- Purulia, 3. Biplab Mahato(20yrs.) S/O- Malinda Mahato of Vill- Rahamda, PS- Hura, Dist- Purulia, 4. Sasadhar Mahato(60 yrs.) S/O- Lt. Premchand Mahato of Vill- Layekdih, PS- Hura, Dist- Purulia, 5. Dhananjay Mahato (25 yrs.) S/O- Ranjit Mahato of Vill- Layekdih, PS- Hura, Dist- Purulia, 6. Alope Mahato (30yrs.) S/O- Ranjit Mahato of Vill- Layekdih, PS- Hura, Dist- Purulia and arrange for its investigation.
