Today (13.07.2020) I SI Partha Sarathi Shit along with JC/1487 Tabrej Ansary and JC/1510 Dipak Gorai were performing day mobile duty vide Hura PS GDE No- 505 Dated- 13.07.2020 and CC No 2027/20 dtd. 13.07.20 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At about 11:45 hrs, when myself along with force reached at Nimtala morh area under Hura P.S. we found 04 (Four) persons namely 1. Md. Adam Gaji (72 yr.) S/O- Lt. Md. Manik Gaji of Vill- Hatiyara, PS- Hatiyara New Town, Dist- Uttar 24 Pargana, 2. Md. Irfan (37 yrs.) S/O- Manjur Alam of Vill- VTC Rajar Hat, PS- Narayanpur, Dist- Uttar 24 Pargana, 3. Md. Jabed (27yrs.) S/O- Md. Safi of Vill- Atgra Purba Para, PS- Baguihati, Dist- North 24 Pargana, 4. Md. Ubesh (30 yrs.) S/O- Lt. Md. Safi of Vill- Atgra Purba Para, PS- Baguihati, Dist- North 24 Pargana. without having mask were moving aimlessly. We warned them regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but they did not pay any heed and also making chaos with the Police party. So finding no alternatives way I arrested all the above noted 04 (Four) persons with the help of my accompany force after observing all formalities regarding arrest and there is every reason to believe that above noted 04 (Four) persons came out from their home without having mask and moving aimlessly for making fun, though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case U/S - 188 IPC and Read with section 51(b) of National Disaster Management Act, 2005 may kindly be started against 04 (Four) arrested persons namely 1. Md. Adam Gaji (72 yr.) S/O- Lt. Md. Manik Gaji of Vill- Hatiyara, PS- Natiyara New Town, Dist- Uttar 24 Pargana, 2. Md. Irfan (37 yrs.) S/O- Manjur Alam of Vill- VTC Rajar Hat, PS- Narayanpur, Dist- Uttar 24 Pargana, 3. Md. Jabed (27yrs.) S/O- Md. Safi of Vill- Atgra Purba Para, PS- Baguihati, Dist- North 24 Pargana, 4. Md. Ubesh (30 yrs.) S/O- Lt. Md. Safi of Vill- Atgra Purba Para, PS- Baguihati, Dist- North 24 Pargana and arrange for its investigation.
