Sub: Report regarding Car Accident

Sir,


I would like to inform you that on 16.07.20 at about 8:30 hrs, when our raiding vehicles were passing in between Saldiah more & Khairipihira more suddenly one two wheeler bearing Reg. no. WB 56A 1213 came in middle of the road, and to save the rider of the bike namely Bijoy Kumar Mondal our driver of vehicle no. WB 55B 1556 suddenly stopped his car and my vehicle Reg. no. WB 55B 1706 hit back side of the vehicle no. WB 55B 1556 & it became twisted and our two vehicles were damaged. My driver and I somehow manage to escape from my vehicle and reached to my front vehicle & ^{rescued} saved my F.O & other staff. Then we went to Ladhucka Block primary health centre for taking first aid. The driver of my car got serious injury, and was admitted to Deben Mahato Sadar Hospital for better treatment & driver of the vehicle no. WB 55B 1556 took first aid from the same hospital.
