
Today (13.07.2020) I SI Partha Sarathi Shit along with C/1494 Manas Mukharjee and JC/1371 Sk. Belal Ansary and HG/1535 Pravas Ruhidas were performing mobile duty vide Hura PS GDE No- 756 Dated- 16.07.2020 and CC No 2060/20 dtd. 16.07.20 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At about 18:30 hrs, when myself along with force reached at Ladhurka morh area under Hura P.S. we found 06 (Six) persons namely (1) Satadal Bouri S/O- Subhas Bouri of Vill- Charra, PS- Purulia (M), Dist- Purulia, (2) Prokash Paul S/O- Lt. Mantu Paul of Vill- Charra, PS- Purulia (M), Dist- Purulia, (3) Falguni Paul S/O- Kirtibus Paul of Vill- Charra, PS- Purulia (M), Dist- Purulia, (4) Ramesh Roy S/O- Ajit Roy of Vill- Nimdiha, PS- Hura, Dist- Purulia, (5) Dipankar Mudi S/O- Dilip Kr. Mudi of Vill- Nimdiha, PS- Hura, Dist- Purulia (6) Murari Mohan Roy S/O- Anath Bandhu Roy of Vill- Nimdiha, PS- Hura, Dist- Purulia .

without having mask were moving aimlessly. We warned them regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but they did not pay any heed and also making chaos with the Police party. So finding no alternatives way I arrested all the above noted 06 (Six) persons with the help of my accompany force after observing all formalities regarding arrest and there is every reason to believe that above noted 06 (Six) persons came out from their home without having mask and moving aimlessly for making fun, though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case U/S - 188 IPC and Read with section 51(b) of National Disaster Management Act, 2005 may kindly be started against 06 (Six) arrested persons namely (1) Satadal Bouri S/O- Subhas Bouri of Vill- Charra, PS- Purulia (M), Dist- Purulia, (2) Prokash Paul S/O- Lt. Mantu Paul of Vill- Charra, PS- Purulia (M), Dist- Purulia, (3) Falguni Paul S/O- Kirtibus Paul of Vill- Charra, PS- Purulia (M), Dist- Purulia, (4) Ramesh Roy S/O- Ajit Roy of Vill- Nimdiha, PS- Hura, Dist- Purulia, (5) Dipankar Mudi S/O- Dilip Kr. Mudi of Vill- Nimdiha, PS- Hura, Dist- Purulia (6) Murari Mohan Roy S/O- Anath Bandhu Roy of Vill- Nimdiha, PS- Hura, Dist- Purulia and arrange for its investigation.
