Sir,

In producing here with 01 (one) arrested accused person namely (i) Amar Nayak (21) S/O Sahilal Nayak of Vill- Gokulnagar, P.S.- Jhalda, Dist. Purulia along with seized Tractor having Reg. No WB55A 5594 attached with a sand loaded trolley. The fact in brief is that today (11.07.2020) evening at about 20:15 hrs received a credible source information that one tractor was carrying sand illegally and coming from Samnagar ghat & going towards Jhalda side. Accordingly, myself along with force left PS to work out the said source information. This refers to Jhalda PS GDE No- 406 Dated- 11/07/2020 & Jhalda PS CC No- 2010/2020 Dated- 11/07/2020. Then, we intercept the said vehicle at Birsha more near Hanuman Mandir (Purulia Ranchi road) under Jhalda PS at about 20:35 hrs and found the above noted tractor was tagged with a trolley being loaded with sand. On asked the driver disclosed his identity as mentioned earlier. On demand, he failed to produce any valid papers in respect of the Tractor and attached Trolley as well as loaded sand though sufficient time was given. During interrogation, the driver of the said tractor confessed that he in convince with the owner of said seized Tractor, Sashibhusan Mishra S/O-Lt. Niranjana Mishra of Jhalda Ojhapara Ward No-03, PS-Jhalda, Dist-Purulia & other is doing this illegal business of sand and he has no Challan/paper for carrying loaded sand. Then, I SI Dibakar Kuiry arrested accused driver of said vehicle (as disclosed during interrogation) as Amar Nayak (21) S/O Sahilal Nayak of Vill- Gokulnagar, P.S. Jhalda, Dist. Purulia under proper arrest memo and also seized the Tractor having Reg. No- WB55A 5594 with attached sand loaded Trolley (approx 100 cft).

On return to P.S., Put the arrested accused person into the P.S. Lock UP after maintaining all formalities, kept the sand loaded seized vehicle at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Amar Nayak (21) S/O Sahilal Nayak of Vill- Gokulnagar, P.S. Jhalda, Dist. Purulia (ii) Owner of the Tractor having Reg. No- WB55A 5594 (iii) Sashibhusan Mishra S/O-Lt. Niranjana Mishra of Jhalda Ojhapara Ward No-03, PS-Jhalda, Dist-Purulia & others under proper section of law.
