Sir,

In producing here with 02 (Two) arrested accused persons namely (i) Laltu Mahato (40) S/O Siyaram Mahato of vill- Patradih, PS- Jhalda, Dist-Purulia and (ii) Sanjay Mahato (40) S/O Ghaltu Mahato of vill- Pusti, PS- Jhalda, Dist- Purulia along with seized vehicle (Dumper) having Reg. No JH02K 0579 loaded with sand approx 250 cft. The fact in brief is that today (30.07.2020) during night mobile duty vide Jhalda PS CC No- 2270 Dated- 30/07/2020 at Birsa more at about 22:15 hrs received telephonic information from SDPO Jhalda that one vehicle (Dumper) having Reg. No JH02K 0579 was detained at Baragram Bagan on Purulia Ranchi Road under PS Jhalda by himself along with his accompany force as the Dumper is carrying sand illegally and coming from Shyamnagar ghat & going towards Kotshila. Accordingly, myself along with force left for Baragram Bagan. Then, we reached at Baragram Bagan under Jhalda PS at 22:35 hrs. and found the vehicle (Dumper) having Reg. No JH02K 0579 loaded with sand approx 250 cft. The vehicle and above noted 02 (Two) persons were handed over to me by SDPO Jhalda. On being asked the detained persons, one disclosed his identity as Laltu Mahato (40) S/O Siyaram Mahato of vill- Patradih, PS- Jhalda, Dist-Purulia and stated that he is the driver of the Dumper. Another one disclosed his identity as Sanjay Mahato (40) S/O Ghaltu Mahato of vill- Pusti, PS- Jhalda, Dist- Purulia and stated that he is the helper of the said Dumper. On demand, they failed to produce any valid papers in respect of the Dumper as well as loaded sand though sufficient time was given for produce valid documents/ challan. During interrogation, the driver of the said Dumper confessed that he in convince with the owner of said Dumper, helper Sanjay Mahato & others is doing this illegal business of sand and he has no Challan/paper for carrying loaded sand. They also confessed that they are doing this illegal business of sand since long. Then, I arrested accused driver and helper of said vehicle (Dumper) under proper arrest memo and also seized vehicle (Dumper) having Reg. No JH02K 0579 with loaded sand (approx 250 cft).

On return to P.S., Put the arrested accused persons into the P.S. Lock Up after maintaining all formalities, kept the sand loaded seized vehicle (Dumper) at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Laltu Mahato (40) S/O Siyaram Mahato of vill- Patradih, PS- Jhalda, Dist-Purulia and (ii) Sanjay Mahato (40) S/O Ghaltu Mahato of vill- Pusti, PS- Jhalda, Dist- Purulia (iii) Owner of the vehicle (Dumper) having Reg. No JH02K 0579 & others under proper section of law.
