With due respect I SI Jayanta Maji of Joypur PS, beg to submit before you that on the night of 04/07/2020 at about 00:25 hrs while myself along with force were performing Night Mobile duty at Ansarypara near Masjid on Joypur-Pundag road as per order of superior vide Joypur PS GDE No-183/20 Date-04/07/2020 & CC No-2712/20 Date-04/07/2020 and found the following person with his Motor Cycle, was coming to Joypur bazaar area, without any face cover mask. Police party detained him at Ansarypara near Masjid on Joypur-Pundag road under Joypur PS. On being asked the following person could not able to give any satisfactory answer for his movement on road and public place, where public movement restriction is going on due to lockdown. On enquire it revealed that the person are the inhabitant of Arsha PS area and without any valid reason/valid pass he was moving at Ansarypara near Masjid on Joypur-Pundag road. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020 and Order dated-29/06/2020 and order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020 & Order No-272-CS/2020 Dated-30/06/2020 are in force. As such the following person violated the order during this pandemic situation. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spared infection of disease dangerous to life.
