

With due respect I SI Milan Manna of Joypur PS, beg to submit before you that on the night of 05/07/2020 at about 22.40 hrs while myself along with force were performing Night Mobile duty at Ropo near hattala on Joypur-Pundag road as per order of superior vide Joypur PS GDE No-221/20 Date-05/07/2020 & CC No-2722/20 Date-05/07/2020 and found the following person, was coming to Ropo area, without any face cover mask. Police party detained him at Ropo Hat tala on Joypur-Pundag road under Joypur PS. On being asked the following person could not able to give any satisfactory answer for his movement on road and public place, where public movement restriction is going on due to lockdown. On enquire it revealed that the person are the inhabitant of Karkara village and without any valid reason/valid pass he was moving at Ropo village. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020 and Order dated-29/06/2020 and order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020 & Order No-272-CS/2020 Dated-30/06/2020 are in force. As such the following person violated the order during this pandemic situation. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused person also tried negligently to sprayed infection of disease dangerous to life. Accordingly the following person his arrested on (05-06/07/2020) at night about 22.45 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S

(1) Tajuddin Ansary (40 yrs) S/o Tohid Anaary of Vill- Karkara, PS Joypur, Dist-Purulia.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/269/270 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005 and arranges its investigation.
