**Sir,**

With due respect I SI Abhijit Singha of Joypur PS, beg to submit before you that on 09/07/2020 at about 09:25 hrs while myself along with force were performing Special Mobile duty at Joypur Bazar area on Purulia-Ranchi road as per order of my superior vide Joypur PS GDE No-395/20 Date-09/07/2020 & CC No-2774/20 Date-09/07/2020 and found the following person, were rooming at Joypur Bazar without any face cover / mask. In spite of several request & remainder they refuse to wear Mask and return back from public place to prevent the spread Covid-19 pandemic. Police party detained them at Joypur Bazar area. On being asked the following persons could not able to give any satisfactory answer for their presence and public place. On enquire it revealed that the persons are they inhabitant of Joypur Bazar area and without any valid reason they were moving at Joypur Bazar. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020 and Order dated-29/06/2020 and order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, Order No-272-CS/2020 Dated-30/06/2020 & Order No-382-I.S.S/2 M-24/2020 date 2<sup>nd</sup> July 2020 of Addl. Chief Secretary Home & Hill Affairs are in force. As such the following person violated the order during this pandemic situation. Moreover they detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons arrested on 09/07/2020 at 09:45 hrs to 10:10 hrs. after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S - 188/269/270 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005 and arrange its investigation.
