With due respect I SI Jayanta Maji of Joypur PS, beg to submit before you that on 29/07/2020 at about 10:45 hrs while myself along with force were performing Special Mobile duty at Joypur Bazar on Purulia-Ranchi road as per order of my superior vide Joypur PS GDE No-1374/20 Date-29/07/2020 & CC No-3053/20 Date-29/07/2020 and found the following persons, were roaming at Joypur Bazar without any face cover / mask. In spite of several request & reminder they refuse to wear Mask and return back from public place to prevent the spread Covid-19 pandemic. Myself along with accompanied force detained them at Joypur Bazar near Arsha more. On being asked the following persons could not able to give any satisfactory answer for their presence at public place. On interrogation it revealed that the persons are not inhabitant of Joypur Bazar and without any valid reason they were moving at Joypur Bazar area, violating the Lockdown order. Lockdown is going on throughout the state of W.B in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020 and Order dated-29/06/2020 and order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, Order No-272-CS/2020 Dated-30/06/2020 & Order No-382-I.S.S/2 M-24/2020 date 2<sup>nd</sup> July 2020 of Addl. Chief Secretary Home & Hill Affairs are in force & Order No-283-CS/2020 Dt-21/07/2020. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons arrested on 29/07/2020 from 11:05 hrs to 11:31 hrs. & 11:35 hrs to 11:57 hrs after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.
