Sir,

With due respect I SI Milon Manna of Joypur PS, I beg to submit before you that on 18/07/2020 at about 21:35 hrs while myself along with force were performing Night Mobile duty at Joypur Bazar area on Purulia-Ranchi road (SH-4A) as per order of my superior vide Joypur PS GDE No-872/20 Date-18/07/2020 & CC No-2913/20 Date-18/07/2020 and found the following persons, were roaming at Arsha More without any face cover / mask. In spite of several request & remainder they refuse to wear Mask and return back from public place to prevent the spread Covid-19 pandemic. Police party detained them at Arsha More area. On being asked the following persons could not able to give any satisfactory answer for their presence and public place. On enquire it revealed that the persons are they are not inhabitant of Arsha More area and without any valid reason they were moving at Atakol side. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02-04/2020, 03/04/2020, 10/04/2020 & 01/05/2020 and Order dated-29/06/2020 and order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, Order No-272-CS/2020 Dated-30/06/2020 & Order No-382-I.S.S/2 M-24/2020 date 2nd July 2020 of Addl. Chief Secretary Home & Hill Affairs are in force. As such the following person violated the order during this pandemic situation. Moreover they detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons arrested on 19/07/2020 at 00:35 hrs to 01:05 hrs. after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S
