Sir,

I, SI Prasanta Datta would like to draw your kind attention that, today (07.07.2020) as per your kind order I was performing Kashipur PS table duty from 8:00 hrs. Today, at around 12: 25 hrs I heard the noise of a procession which seemed to be coming towards our Kashipur PS gate. C/74 Kamakhya Prasad Mondal was performing his sentry duty. Within a moment I came to find that a mob of about 30/35 persons had assembled near our PS gate. I along with other officer and force namely ASI Giridhari Roy, C/08 Tapan Kumar Mahato, JC/ 977 Tarun Kadam, LC/ 92 Mousumi Dutta went to our PS gate. I found that about 30/35 persons including females have sit down near our PS gate and have totally blocked out entry gate. Almost all of them have banners and flags of BJP and showing agitation. Among them I noticed (1) Subhadip Paramanik S/O Basudeb Paramanik of vill Kashipur, PS Kashipur Dist Purulia (2) Jayanta Goswami S/O Sunil Goswami of vill Dhanera, PS Kashipur Dist Purulia (3) Swapan Chowdhury S/O Lt Aswini Chowdhury of vill Kashipur Near Water tank, PS Kashipur Dist Purulia (4) Basanta Pattanaik S/O Lt Mohan Pattanaik of vill Tara P.S Kashipur Dist Purulia and (5) Jayanta Pal S/O Lalmohan Pal of vill Kashipur Upar Para, PS Kashipur Dist Purulia whom I know as local BJP leaders and they were leading the mob.

I requested the mob to withdraw the gathering from our PS gate and asked them to submit complaint if they had any. But they did not hear me at all. I also tried to convince the above noted leaders who were leading the mob to disperse but they did not care. I tried to make them aware of the guide lines of Covid 19 pandemic and to maintain social distance but they did not pay any heed. None of them were wearing mask. Consequently, it reasoned to believe they violated the order and disobeyed the direction during this Pandemic situation duly promulgated by Govt. of India vide order No. 40-3/2020-DM-I(A) dated 1/5/2020read with the order of Govt. of West Bengal vide Memo No 103-CS/2020 Dated 04/05/2020. For their blockage at the main gate both the entry of common people and the exit of police personnel was fully disrupted. They did continue their activities for about 55 minutes and then they got dispersed.

So a specific case may kindly be started against the supra noted persons and 30 others BJP supporters and arranged for it's investigation.
