Mahespur, P.S. Kenda, Dist. Purulia due to previous grudge blocked and gharow inside the house courtyard for the purpose of killing your petitioner with furtherance of common intention and they all carrying deadly weapon like shord, axe, latmi etc and suddenly one of the male accused

flung his sword and heated on the right leg of the complainant and your complainant sustained bleeding injury upon his right leg and fell down on the earth and on the same time as and when complainant earth ridden condition suddenly one of the accused trying to heat upon the head of the complainant but some how complainant moved from the place and the axe was heated on the earth.

2. That leaving hue and cry wife of the complainant and some village people rushed at the spot then the accused persons snatched the amount of Rs.5000/- which was kept inside of the upper pocket of the shirt and a chain from his neck.

3. That incident took place in presence of some of the witnesses and they trying to raised objection but the accused persons did not hear any heed.

That as and when accused persons went away after assaulting and snatching the Rs.5000/- and a neck chain by the help of witnesses as well as some village people your complainant went at the Chahalpore P.P.L.C. for treatment and after dressing and taking injection and medicine your petitioner went at the P.S. and gave a written complaint but the P.S. did not take any steps and then
