Sub: Request for lodging FIR against arrested accused persons.

Sir,

In producing herewith 03 (three) arrested accused persons namely (i) Bablu Majhi (25 Yrs), S/o- Bhurkhu Majhi (ii) Baneswar Majhi (26 Yrs.), S/o- Rathu Majhi both are of Vill- Sagma, PS- Balarampur, Dist- Purulia & (iii) Goutam Majhi (32 Yrs.), S/o- Surya Majhi of Vill- Dhadkidih, PS- Barabazar, Dist- Purulia along with Memo of Arrest, Inspection Memo & other relevant papers.

I beg to state that today (i.e. 11/07/2020), as per direction I along with JC/559 Bubun Mahanty, NVF/826 Ramcharan Mahato all are of Kenda PS engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding Lockdown Disaster Management Plan. This refers to Kenda PS GDE No. 354 dtd. 11/07/2020. Accordingly, I along with force visited different areas under Kenda PS and at about 17.15 hrs. when we reached at Kenda Thana Morh area found that a gathering appeared at Kenda Thana Morh and found above noted arrested accused persons were gossiping each other without wearing of mask during this pandemic situation.

So, there is every possibility that the above noted accused person gossiping each other without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to life and violated Government rule.

Therefore, I pray a specific case may kindly be started against (i) Bablu Majhi (25 Yrs), S/o- Bhurkhu Majhi (ii) Baneswar Majhi (26 Yrs.), S/o- Rathu Majhi both are of Vill- Sagma, PS- Balarampur, Dist- Purulia & (iii) Goutam Majhi (32 Yrs.), S/o- Surya Majhi of Vill- Dhadkidih, PS- Barabazar, Dist- Purulia as per proper section of law.
