In producing herewith 02 (Two) arrested accused persons namely (i) Sanjoy Mahali (19yrs) S/O Kalyan Prasad Mahali of Vill- Majhihira, PS- Manbazar , Dist- Purulia & (ii) Mantu Mahali (24yrs)S/o- Lahi Mahali of Vill- Keshargoria, PS- Manbazar, Dist- Purulia along with Memo of Arrest, Inspection Memo & other relevant papers.

I beg to state that today (i.e. 14/07/2020), as per direction I along with C/1492 Dilip Kr. Gorain and C/181 Rabban Sekh both of Kenda PS engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding Lockdown Disaster Management Plan. This refers to Kenda PS GDE No. 447 dtd. 14/07/2020. Accordingly, I along with force visited different areas under Kenda PS and at about 13.00 hrs. When we reached at Kenda Sardardi Morh area found that a gathering appeared at Kenda Sardardi Morh and found above noted arrested accused persons were gossiping each other without wearing of mask during this pandemic situation.

So, there is every possibility that the above noted accused person gossiping each other without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to life and violated Government rule.

Therefore, I pray a specific case may kindly be started against (i) Sanjoy Mahali (19yrs) S/O Kalyan Prasad Mahali of Vill- Majhihira, PS- Manbazar , Dist- Purulia & (ii) Mantu Mahali (24yrs)S/o- Lahi Mahali of Vill- Keshargoria, PS- Manbazar, Dist- Purulia as per proper section of law.
