Sub: Request for lodging FIR against arrested accused persons.

Sir,

In producing herewith 02 (two) arrested accused persons namely (i) Bijoy Sahis (21 Yrs), S/o- Lt. Bipa Sahis (ii) Bijoy Bouri (21 Yrs.), S/o Mangal Bouri both of Vill- Rajnawgarh (Amdih), PS- Kenda, Dist- Purulia along with Memo of Arrest, Inspection Memo & other relevant papers. I beg to state that today (i.e. 25/07/2020), as per direction myself along with C/1255 Ajoy Kr. Bouri and C/1157 Khaja Sams Basar all are of Kenda PS engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding Lockdown Disaster Management Plan. This refers to Kenda PS GDE No. 829 dtd. 25/07/2020. Accordingly, myself along with force visited different areas under Kenda PS and at about 18.30 hrs. When we reached at Rajnawgarh more found that a gathering appeared at Rajnawgarh more and found above noted arrested accused persons were gossiping each other without wearing of mask during this pandemic situation.

So, there is every possibility that the above noted accused person gossiping each other without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease which dangerous to human life and violated Government rule. Hence I arrested the above noted accused persons with a view to start specific case against them.

I Therefore pray that a specific case may kindly be start against (i) Bijoy Sahis (21 Yrs), S/o-Lt. Bipa Sahis (ii) Bijoy Bouri (21 Yrs.), S/o Mangal Bouri both of Vill-Rajnawgarh (Amdih), PS-Kenda, Dist-Purulia as per proper section of law.
