**Sub:** Request for lodging F.I.R. against arrested accused Bikash Ch Mahato & one another.

**Sir,**

In producing here with 02 (Two) arrested accused namely 1) Bikash Ch Mahato (28)s/o-Anil Ch Mahato of vill-Garafusra, PS-Purulia(M),Dist-Purulia 2)Pratik Ch Mahato (32), s/o-Lt Manbhul Mahato of vill-Sindri-Chasmore, PS-Purulia(M),Dist-Purulia

I SI Ramu Gurung of Kotshila PS do here by lodged a complaint against above noted 02 accused persons to the effect that on 16.07.2020 at about 18:45 hrs as per direction we were engaged for spl checking duty at Kotshila bazar infront of Kotshila Rly Station on Kotshila Jhalda main road that found 02 persons coming from Rakhbore side without any mask/facial cover. We detained them. On being asked the following persons could not be able to give any satisfactory answer for that movement on the road or they could not be able to give reasonable-ground for this movement. So there is every reason to believe that the said three persons came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, and 10/04/2020 and also order no 79-CS/2020 Dated-12.04.2020 &79-CS/2020 Dtd-12.04.2020 & memo no-272-CS /2020 Dated:-30.06.2020,order no-382-I-S.S-2 M-24/2020 Dtd-02.07.2020 of Addl CS Home & hill affairs are in force. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 31.07.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested the above noted 02(Two) accused persons in between 19.05 hrs & 19.15 hrs on 16.07.2020, brought them to P.S. I offered them for medical treatment but they denied.

Hence I therefore pray that a specific case may kindly be started against above mentioned persons U/S-188/34 IPC & Section 51 in the National Disaster Management Act, 2005.
