Sir,

In producing herewith one seized vehicle (Dumper) bearing registration No JH 05 AQ 7534, loaded with sand. The fact of the case in brief is that on 01/07/2020 I along with force were on evening mobile duty vide Manbazar PS G.D.E No-25, dtd-01/07/2020, C.C No-1460, dtd-01/07/20 on Bankura Manbazar Road(SH-4). During mobile duty on 01/07/20 at about 20:25 hrs received a credible source information that the above noted vehicle(Dumper) is coming from Basudih side towards Indkuri more loaded with sand without valid paper. After receiving this information we were proceeding towards Indkuri more under Manbazar P.S. When we reached near Indkuri more under Manbazar P.S, found that the above noted vehicle(Dumper) was coming from Basudih village side. On seeing the Police party the driver of the said Vehicle(dumper) stopped the dumper in a distance from Indkuri more and tried to unload the sand, loaded in the said vehicle (dumper). We rushed to the vehicle and the driver then fled away after keeping the vehicle near Indkuri more at 21:05 hrs. We searched the said vehicle and found that the vehicle is loaded with sand. I searched for any valid documents in respect of sand loaded in the dumper as well as the valid documents in respect of that dumper but nothing found. Hence I seized the vehicle bearing registration No JH 05 Q 7534 loaded with sand amount approx 600CFT of sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said vehicle to Manbazar P.S. As such there is every reason to believe that the driver and owner of the vehicle bearing registration No JH 05 AQ 7534 with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S- 379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of vehicle (Dumper) bearing registration No JH 05 AQ 7534 may kindly be started and arrange for its investigation.
