Sir,

In producing here with 03(Three) arrested accused persons namely (i) Jiten Mahato(23 yrs approx) S/O Nepal Mahato (ii) Samit Mahato(21 Yrs approx) S/O Sriram Mahato both of village-Chepua Majhpara, PO – Kasidih, PS- Manbazar, Dist-Purulia & (iii) Brihaspati Mahato(19 Yrs approx) S/O Srabon @ Saraban Mahato of village- Ichadih, PO – Bishri, PS- Manbazar, Dist-Purulia along with seized motor Cycle, seizure list, memo of arrest, Inspection Memo & other relevant papers nothing.

I beg to state that today (19.07.2020), I was directed to find out whether the lock down has been implanted properly at Manbazar Post Office More area or not. This refers to Manbazar PS GDE No- 946 Dtd. 19.07.2020. Accordingly, I had been to Manbazar Post Office More area at about- .18:35. hrs I found that the above noted persons with their Motor Cycle, were roaming aimlessly at bazaar area. Myself along with force detained them at Manbazar Post Office More On Bandwan -Manbazar road under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 & 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till now. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life.

I arrested them for Disobedience to order duly promulgated by public servant; after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. More over they driven the motor cycle on public way in rush and negligently as to endanger to human life. On being asked they did not produce the valid documents in respect of said motor cycle as well as driving license.

I seized

a) One Honda Shine SP.125(Red & Black Colour) Bearing registration no- WB56P/1912 and engine no- JC73E-T-2228666 and Chassis No- ME4JC738LJT099370 driven by Jiten Mahato(23 yrs approx) S/O Nepal Mahato of village- Chepua Majhpara, PO – Kasidih, PS-Manbazar, Dist- Purulia with proper seizure list duly signed by the accused persons and witnesses.

All the process was done in between 18:55 hrs and 19:35 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present as witness in the seizure process. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar through duty officer SI Soumen Kr. Panda for taking necessary action as per law. I handed over all the relevant papers, seizure list, seized motor cycle, Memo of arrest, Inspection Memo.
