Sub: Complain to start a specific case.

Sir,

I, SI Kalyan Kumar Sakha of Neturia PS, Dist- Purulia do hereby lodge a written complaint against Md. Ali (35) S/O- Md. Kasim of Vill-Saltore, PS-Neturia, Dist-Purulia, Owner of Shoe Shop styled as Babu Shoe Park at Parbelia Bazar to the effect that today on 09.07.2020 while I along with force C/1353 Atanu Ganguly, C/1304 Dhananjay Mondal and C/1303 Biswanath Majhi all are of Neturia PS as per direction engaged in special mobile duty in Neturia PS area vide Neturia PS GDE No- 368 and CC No- 1918/20 dated 09.07.2020 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Parbelia Bazar at about 15:45 hrs found that the above noted person was selling shoes to the customers in his shop without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation. I took photograph of the Shoe shop along with owner and customers left the place on seeing the Police team.

So, there is every reason to believe that the above noted person was selling shoe in his shop at Parbelia Bazar under Neturia PS without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule.

Therefore, I pray a specific case may kindly be started against accused Md. Ali (35) S/O- Md. Kasim of Vill-Saltore, PS-Neturia, Dist-Purulia U/S- 188 IPC and 51 (1) (b) Disaster Management Act, 2005 as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
