Narayan Bauri of Vill-Baruipara (3) Dhananjoy Bauri (22) S/O- Meghnath Bauri of Baruipara and (4) Mritunjoy Routh (32) S/O- Madan Routh of Vill-Pochheria, all are under PS-Neturia, Dist-Purulia, I, SI Kalyan Kumar Sakha of Neturia PS, Dist-Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 12.07.2020 while I along with ASI Shibaram Bauri and C/584 Madhab Chandra Majee, C/1224 Gajan Murmu and C/1260 Santosh Saren all are of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 523 and CC No- 1951/20 dated 12.07.2020 for implementation of Government rules regarding lockdown Disaster Management Plan. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) Disaster Management Act, 2005 and arrange for its investigation.
