Sub: Complaint to start a specific case.

Sir,

In producing herewith 03 (three) arrested accused persons namely (1) Tarani Dik Pati (53) s/o late Handu Dik Pati of Nabagram PS -Neturia Dist -Purulia (2) Tapan Singh (49 yrs) s/o Sankar Singh of Dubrajpur PS Saltore Dist Bankura and (3) Mohan Bagdi (49 yrs) s/o late Fatu Bagdi of Barakin (Anara) PS Para Dist Purulia , I, SI Bablu Ghosh of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 14.07.2020 as per order I along with ASI Tarapada Mete , C/1224 Gajan Murmu, C/480 Uttam Bauri and C/1260 Santosh Saren all are of Neturia PS were engaged special mobile duty in Neturia PS area, which refers to Neturia PS GDE No- 593 and CC No- 1965/20 dated 14.07.2020 for implementation of Government rules regarding lockdown Disaster Management Plan ad while we reached at Sarbari Morh near Roy Jeweler Shop under PS Neturia Dist Purulia at about 13:45 hrs we found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I took photograph all of them and asked them about their presence at Sarbari Morh but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) Disaster Management Act, 2005. I interrogated them and during interrogation they disclosed their identity noted above. After interrogation I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police U/S-188/34 IPC & 51 (1) (b) Disaster Management Act, 2005 and informed ground of arrest.

Therefore, I am requesting you to start a specific case against the above noted arrested accused persons U/S- 188/34 IPC and 51 (1) (b) Disaster Management Act, 2005 and arrange for its investigation.
