Sir,

In producing herewith 07 (Seven) arrested accused persons namely (1) Ganesh Paswan (56) S/O- Lt. Budhu Paswan of Vill- Ranipur Colliery, (2) Bhola Chowdhury (30) S/O- Kameswar Chowdhury of Nowada, (3) Paban Rajak (32) S/O- Naresh Rajak of Saltore Rajak Para, (4) Rahul Kr. Rabidas (19) S/O- Sunendar Rabidas of New Colony, (5) Dulal Gope (45) S/O- Gopal Gope of Parbelia Gram (6) Paresh Bouri (45) S/O- Baru Bouri of Dubeswary Colliery (7) Ukil Show (48) S/O- Lakhan Show of Parbelia Amdanga, all under PS-Neturia, Dist-Purulia, I, SI Bablu Ghosh of Neturia PS, Dist-Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 25.07.2020 as per direction I along with ASI Dibyendu Mahato, C/1140 Dayamay Mahato, NVF-578 Niranjan Hembram all are of Neturia PS were engaged special mobile duty in Neturia PS area, which refers to Neturia PS GDE No-1118 and CC No- 2088/20 dated 28.07.2020 for implementation of Government rules regarding lockdown Disaster Management Plan and while we reached at Parbelia Bazar under PS Neturia Dist Purulia at about 10:15 hrs we found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I took photograph all of them and asked them about their presence at Parbelia Bazar but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) Disaster Management Act, 2005. I interrogated them and during interrogation they disclosed their identity noted above. I also took photograph all of them. After interrogation I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police U/S-188/34 IPC & 51 (1) (b) Disaster Management Act, 2005 and informed ground of arrest.

Therefore, I am requesting you to start a specific case against the above noted arrested accused persons U/S- 188/34 IPC and 51 (1) (b) Disaster Management Act, 2005 and arrange for its investigation.
