Sub:- Complaint to start a specific case.

Sir,

In producing herewith the arrested aced Panu Mallick (22) S/O- Durjodhan Mallick of Vill-Pabra, PS-Raghunathpur, Dist-Purulia along with seized Tractor bearing No- WB 81/1731 loaded with stone approx 100 cft. under proper seizure list. The fact of the case in brief is that I, ASI Rabin Mukherjee, now deputed at Raibandh Camp under Neturia PS, today on 22.07.2020 at about 16:30 hrs received a credible source information that one Tractor was coming from Naragoria side towards Sidpur side loaded with stone illegally. Accordingly I intimated the matter to you over mobile phone and as per your direction I, ASI Rabin Mukherjee along with C/1536 Kartik Chowdhury and JC/266 Baban Das all of Raibandh camp under Neturia PS left to work out the information and while we reached at Raibandh Hattola at about 17:10 hrs found that the above noted Tractor was coming from Naragoria side. I intercepted the Tractor and found the registration number given by my source is matched. On search found the Tractor is loaded with approx 100 cft stone. I asked the driver to produce any valid documents in respect of stone loaded in the Tractor as well as the valid documents in respect of that Tractor but he failed to produce any valid document in respect of stone and Tractor. As such there is every reason to believe that the driver and owner of the Tractor with ill motive were transporting the stone illegally as per their regular practice without any valid document in support of carrying stone. So, they committed offence punishable U/S- 379/411/413/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957. Hence I arrested the driver Panu Mallick (22) S/O- Durjodhan Mallick of Vill-Pabra, PS-Raghunathpur, Dist-Purulia after observing all formalities and seized the Tractor bearing No- WB 81/1731 loaded with stone approx 100 cft under proper seizure list in presence of police witnesses duly signed by them and I brought the said Tractor to Neturia P.S.

Therefore, I pray before you that a case against the driver namely Panu Mallick (22) S/O- Durjodhan Mallick of Vill-Pabra, PS-Raghunathpur, Dist-Purulia and owner of Tractor bearing No- WB 81/1731 may kindly be started and arrange for its investigation.
