Sub: Prayer for starting a specific case.

I, SI Dhirendranath Mondal of DEB, Purulia, do here by lodge complaint against Paresh Gorain (48 Years) S/O- Lt. Ratan Gorain of Vill-Dudhiapani, PS-Neturia, Dist-Purulia being produced seized articles (i) Rice (07) Seven Bags, fully loaded in packet condition of 50 Kg. each marked as (Grade verity of Rice, A/C SCSC Ltd., Kharif Marketing season 2019-20, BARAGORE CML 5100081376, Manufactured in India) and (ii) Fortified atta (110) One hundred and ten packets in plastic sealed packets, 950 gram each marked as (WB Govt. Food and supply dept., Shib Shakti Industries) with proper seizure list along with the arrested accused Paresh Gorain (48 Years) S/O- Lt. Ratan Gorain of Vill-Dudhiapani, PS-Neturia, Dist-Purulia to the effect that today 24.07.2020 received a credible source information to the effect that one Paresh Gorain (48 Years) S/O- Lt. Ratan Gorain of Vill-Dudhiapani, PS-Neturia, Dist-Purulia owner of the grocery shop styled as "Maa Manasa Bhandar" at Vill-Dudhiapani, PS-Neturia, Dist-Purulia, procured PDS articles such as rice and fortified atta by illegal means for selling the same in higher prices for wrongful gain depriving the genuine ration holders and to sale in open market for clandestine business purpose.

Accordingly being directed by the Dy. SP, DEB, Purulia I along with officers and forces of DEB, Purulia arrived at Neturia PS and noted the fact vide Neturia PS GDE No-1058 Dt. 24.07.2020 at 09:05 hrs and submitted requisition to O/C Neturia PS for providing Police Assistance for holding search and raid. Hence myself along with officers and forces of DEB, Purulia (1) ASI Swapan Chakraborty (2) HG Benimadhab Char and (3) HG Shyamapada Mahato accompanied with officer and forces of Neturia PS left for Dudhiapani village under this PS area to work out the information. On arrival at Dudhiapani village at 11:05 hrs asked local people viz. Balaram Mahato S/O- Lt. Haripada Mahato and Pranab Banerjee S/O- Sujan Banerjee both of Dudhiapani village to assist us for holding search and raid in the house premises and grocery shop of Paresh Gorain S/O- Lt. Ratan Gorain of Vill-Dudhiaparti, PS-Neturia, Dist-Purulia as well as to work out the information. After observing the all formalities relating to search, myself along with accompanied officers and forces in presence of local people searched the house premises and grocery shop of Paresh Gorain from 11:15 hrs and found the above noted PDS goods were staged inside a room attached to his kitchen in his house yard and inside his grocery shop. On asking for staging such PDS goods said Paresh Gorain, failed to produce any documents or authorization or to supply any satisfactory account in respect of staging of those articles (PDS goods). During search it (One hundred and ten) packets of fortified attas (PDS items) are staging in his shop for selling those to the common people. Thereafter proper weighment of the above PDS items, I seized those articles in between 12:15 hrs to 13:25 hrs in presence of local witnesses under proper seizure list from the possession of the above shop owner duly signed by the witnesses and possessioner.

It is reason to believe that the owner of the grocery shop namely Paresh Gorain in connivance with others made conspiracy to sale those PDS goods in open market at high price depriving the poor and needy genuine ration holders. Accused Paresh Gorain running such type of unlawful business since long with the help of some dishonest ration dealers and others and thereby causing deprive to the genuine poor ration holders and of the society after forming an illegal business racket.

During local enquiry it has also been ascertained that the above accused person running such illegal business since long with others. Due to such unlawful activates said Paresh Gorain (48 Years) S/O- Lt. Ratan Gorain of Vill-Dudhiapani, PS-Neturia, Dist-Purulia committed offence punishable U/S- 406/407/120(B) IPC & 7(i)(a)(b) E.C. Act 1955/ 51 (b) of National Disaster Management Act 2005, and as such he comes under purview of law for committing such offence. Hence I arrested him after issuing arrest memo with observing all formalities and informing grounds of arrest.

Therefore I, pray before you to start a case U/S- 406/407/120(B) IPC & 7(i)(a)(b) E.C. Act 1955/51 (b) of National Disaster Management Act 2005 against accused Paresh Gorain (48 Years) S/O- Lt. Ratan Gorain of Vill-Dudhiapani, PS-Neturia, Dist-Purulia and some dishonest dealer and others.

As per order of Dy. SP, DEB, Purulia SI Sajol Mishra of DEB, Purulia will investigate the case.
